## Key Purpose of the Job

- To take responsibility for planning and implementing appropriate work programmes for all children in accordance with the current School Teacher's Pay and Conditions document, having due regard to the requirements of the National Curriculum, LA and school policies.

## Main Activities

### Teaching:

- To take responsibility for planning and implementing appropriate work programmes for all children in the designated class, within the framework of national and school policies.
- To ensure a close match between the learning experiences offered, and the individual needs of the children in the class, so as to give each child an opportunity to achieve to the maximum of his/her capability
- To maintain assessment records and report on pupils progress to senior staff and to parents and carers, in accordance with school policy
- To set high expectations which inspire, motivate and challenge pupils. Where possible, to make sure that the majority of the children's work is closely linked to first-hand practical experience.
- To provide children with opportunities to manage their own learning and become independent learners
- To arrange for resources, equipment and materials to be available in such a way that they are properly cared for, easily accessible and will encourage the children to become more responsible for their own learning
- To create a secure, safe, happy and stimulating classroom environment, maintaining the highest standards of organisation, and discipline.
- To maintain a high standard of display and order both in the classroom and in other areas of the school
- Promote good progress and outcomes by pupils
- To demonstrate good subject knowledge and curriculum knowledge
- To plan and teach well-structured lessons
- Adapt teaching to respond to the strengths and needs of all pupils
- To make accurate and productive use of assessment
- To make appropriate educational provision for children with SEN, GTMA and those learning EAL

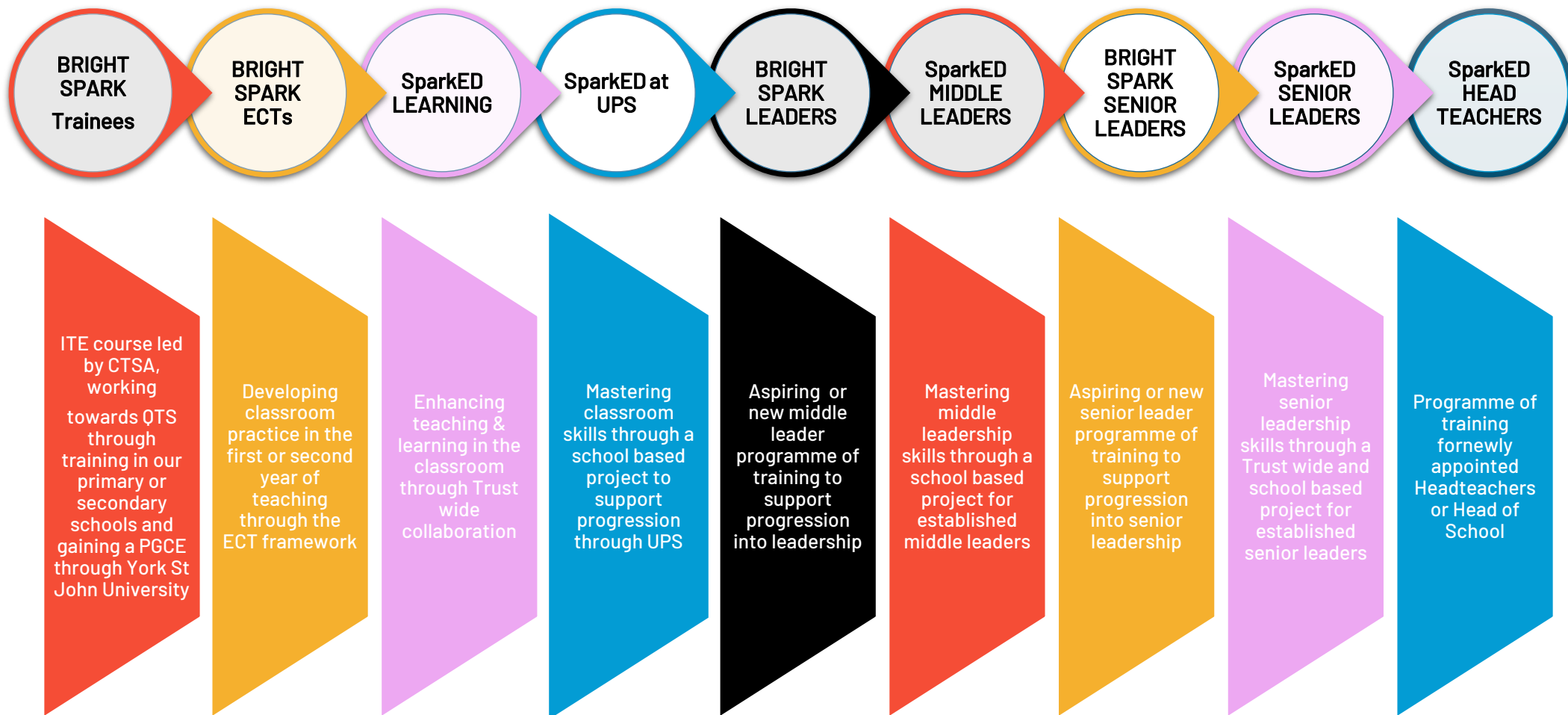
